## HUNTER TO GUIDE RATIO

With each of our hunts we strive to have one guide available for every two hunters to give you the best possible opportunity to fill your tag. For an additional \$175 a day, you can have the opportunity to work with one of our experienced guides one-on-one.

## BOOKING POLICY & PAYMENT

We operate on a first-come, first-serve basis and encourage all clients to promptly submit a 30% deposit in order to hold the date they choose. We feel this provides equal opportunities for all. The remaining balance must be paid 30 days prior to trip date.

If you do not draw out then you will be refunded your deposit within two weeks, or you can use that money to book a hunt for the following year or until a license and tag can be obtained.

## REFUND POLICY

We offer a full refund on all hunts up until June 1st of the year of your hunt. Any cancellations after June 1st we offer a 50% return up until 30 days before your hunt, and if canceled less than 30 days prior to your booked hunt, it is non-refundable.

## ADDITIONAL TRIP INFORMATION

**TRIP NOTES:** A four-wheel drive vehicle is recommended to make the drive to the trailhead. Nearest airports are Salt Lake City, UT and Jackson, WY and are within a 2 ½ hour drive to our headquarters in Cokeville, WY. Plan for two extra days for drive/pack-in. Additionally, we do not hunt on Sundays and therefore offer Sunday as a free day in camp. For example: if your hunt is on a Monday, we will pack you in on the Saturday before at no extra cost.

**ALCOHOL POLICY** Alcohol is strictly prohibited while hunting out in the field.

## Wyoming Hunt Information

A non-resident of Wyoming must enter a draw to have a chance at acquiring a license to hunt in the state for Elk, Deer, Antelope and Moose. To draw out, you must have enough preference points. When you put in for the hunt of choice, it is required that you purchase the Hunting License at that time. If you draw out, the license and a copy of the regulations will be mailed to you within 15 days of the draw results. If you don't draw out, then they will reimburse you, minus the nonrefundable application fee of \$15. Bear tags are over the counter and you do not need to draw out.

### PREFERENCE POINTS

You can purchase one preference point per year for each species (antelope, deer, elk, moose, sheep). Purchase a preference point during the application period of July 1 to October 31, of each year.

Each hunter is allowed one point per year. You can purchase your preference points or find out more on the Wyoming Game and Fish Website: <https://wgfd.wyo.gov/hunting/preference-points> OR you can call 307-777-4600.

**WAIVER & RELEASE OF LIABILITY  
CROOKED SKY OUTFITTERS, LLC**

**Please read the following carefully as this is a legally binding document. If you have any questions, please have them answered before signing this document. A waiver needs to be completed for each participant.**

**1. PARTICIPATION WAIVER.** In consideration of being permitted to participate in the various hunting, fishing, horseback riding, and other activities (the "Activities") offered by Crooked Sky Outfitters, LLC ("Crooked Sky"), I, the undersigned being above age eighteen (or the legal guardian or parent of the minor named below) acknowledge and agree that that I understand the dangers and risks inherent with the Activities, including but not being limited to those associated with hunting, fishing, hiking, horse riding, canoeing, fishing, wildlife, weather, firearms, archery, preparing food, consuming food, and working with related tools and appliances.

I HEREBY ACCEPT AND ASSUME ALL RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS AND/OR DAMAGES FOLLOWING ANY INJURY, DISABILITY, PARALYSIS OR DEATH. I DO HEREBY WAIVE, RELEASE, AND FOREVER DISCHARGE CROOKED SKY, ITS OWNERS, AFFILIATED COMPANIES, INSTRUCTORS, OFFICERS, AGENTS, AND EMPLOYEES (COLLECTIVELY THE "RELEASEES") FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, ACTIONS OR CAUSES OF ACTION FOR COSTS, EXPENSES, OR DAMAGES TO PERSONAL PROPERTY OR PERSONAL INJURY, OR DEATH, WHICH MAY ARISE FROM MY PARTICIPATION, OR MY CHILD'S PARTICIPATION, IN THE ACTIVITIES (THE "CLAIMS").

I understand and admit that my participation, or child's participation, in the Activities is completely voluntary. I assume full responsibility for any injuries or damages resulting from my participation, or child's participation, in the Activities including responsibility for using reasonable judgment in all phases of participation of the program and travel to and from the location of the Activities. I recognize and understand that the Activities may be hazardous, that my participation, or child's participation, is solely at my own risk, and that I assume full responsibility for any resulting injuries and damages. I acknowledge and agree that any participation in Activities involving water will not be supervised by Crooked Sky in any way, that any swimming is done at my own risk, and that I am required to wear a life jacket before heading out on any water in a boat or canoe or to swim.

I HEREBY RELEASE, DISCHARGE AND CONVEYANT NOT TO SUE THE RELEASEES FOR ANY CLAIMS. I FURTHER AGREE TO REIMBURSE ALL COSTS TO THE RELEASEES THAT ARISE FROM A CLAIM, INCLUDING DAMAGES, LEGAL FEES AND/OR COSTS. FURTHERMORE, I AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES FROM ANY DAMAGES, EXPENSES, FEES, ATTORNEY FEES, COSTS, LIABILITY, DAMAGE, OR ANY OTHER EXPENSES INCURRED DUE TO A CLAIM MADE AGAINST ANY OF THE RELEASEES.

I also understand that this agreement binds my heirs, executors, administrators, and assigns as well as myself. If any provision of this Agreement is found to be unenforceable, the remaining terms shall be enforceable and the unenforceable provision shall be adjusted as little as possible so as to make the provision enforceable under applicable law.

**2. FOOD ALLERGY/DIETARY RESTRICTION WAIVER.** I acknowledge that I am responsible to inform Crooked Sky and the guide, officer, agents, employees, and volunteers of any and all food allergies, dietary restrictions or other related medical information for myself or my child.

**3. MEDIA RELEASE.** I consent to and allow any use and reproduction of any and all photographs or videotapes taken of myself or my child during the Activities unless I have otherwise notified Crooked Sky in writing. This includes the right to use any such photographs or videotapes in connection with advertising and social media.

**I acknowledge that I have thoroughly read and understand this entire agreement, and I agree to be legally bound by it. My signature below indicates that I have read this entire agreement, understand it completely, understand it affects my legal rights and waives the right to sue as outlined herein and I agree to be bound by its terms. This agreement is governed by the laws of the State of Wyoming and if there is a dispute relating to this agreement the prevailing party shall be entitled to its attorney fees and costs.**
